Jefferson County Board of Governors

- Since inception in 1959, Jefferson Hospital Association has leased the hospital property from Jefferson County.
- By state law, each County that owns a hospital has a Board of Governors that is responsible for oversight of the hospital. The Board of Governors can manage and operate the hospital themselves or can lease it, such as the case in Jefferson County.
- The Jefferson County Board of Governors most recently met in June 2022 to consider, and subsequently approve, an extension of the lease with JHA through December 31, 2099.
- JHA leadership has requested a meeting with the Board of Governors in October to review the material from this Annual Meeting.
